Mr. John Coleman addressed the Board regarding California Education Code 49079 expressing concern that teachers have not been provided with information if a student in their classroom has engaged, reasonably suspected in engaging in any of the acts described in the subdivision.

Mr. Tom Gillcrist, Mr. James O'Donnell, and Mrs. Terese Gillcrist, all addressed the Board with their concerns on school security approved in the Bond measure and the possibility of not moving forward with what was approved with Bond monies.

Staff members, teachers, alumni, and SEIU President, all addressed the Board on their concerns regarding the layoffs and reduction in work hours of classified staff. They expressed their concerns how these changes will affect the students. They also expressed their concerns on how the reduction in hours will personally affect their home life after many years of fulltime employment with the District.

Dr. Jennifer Schiebert addressed the Board with her concerns that FHS will cut or not offer many AP and Performing Arts courses. Feels students will be the ones to suffer from less class choices
