All members of the Association are past FHS students and graduates. They look forward to continued communication with our school sites and encouraged the district to support our local business.

# A. Report from Camp Pendleton Representative: No report.

**B.** Report from Board Members: Ms. Ludwig congratulated everyone on a great Homecoming.

Ms. Koehler reported that the Student of the Month Breakfast has now started. Very proud of our Student Board Representative Gabrielle for being named Student of the Month. Ms. Koehler also read a letter sent to her by our past Student Board Rep. Tristan Curnow.

Mr. Goodlake expressed how proud he is of our new JRTOC Program here on campus. It's a wonderful program with 120 students and a waiting list of 15.

Mr. De Meo shared that he was able to teach two classes for Constitution Day at Fallbrook High School and teach students about the Constitution. He provided a brief outline to the Board about what he taught in those classes. At the end of one of the classes a student presented him with a drawn portrait of him. He will be framing and placing that picture in his office. Mr. DeMeo was truly moved by the student's gesture.

Mr. O'Donnell reported that he was able to visit FHS and visit the Houses. He spoke with students and staff. He knows things are moving in the right direction. He was able to visit the JROTC Program and was very impressed with the team and the program. It's great to see that 38% of the students in the program are girls and they have taken on leadership roles. Also, shared that the tri-tip from the Ag Dept. was as delicious as always.

C. Report from Student Board Representatives: Gabrielle reported that Homecoming was a huge success. It brought in about 500 students and a profit of about \$10,000. Many students commented on how it was the best experience they have had. ASB will be working with its Leadership class on the quality of leadership. The next focus will be the Winter Dance which this year will be a formal.

Rafael reported that Ivy HS was looking for a new name for their after school ASSETs Program. He asked that the Board and the audience participate in voting for a name. The winner was Tiger Territory. He shared that Mr. Smith took his photography class to Myrtle Creek on a field trip and it was a great success. Two classrooms at IHS have received new furniture. IHS now has a new Instagram account. Mr. Gage has introduced new things to the PE class such as horeshoe and wiffle ball, and the ASSETs Program has art, golf and cooking classes.

**D. Reports from Principals:** Mr. Boone reported that the first progress reports went out last week. Students have plenty of time to raise their grades. He shared that Dr. Eileen Straus, Vice President of the California State School Board would be on campus on Monday, October 17<sup>th</sup>. FHS is paying for the PSAT Exams for all students. Mr. Boone also reported that the great shake drill would be taking place next Thursday and the Legislative Team visit would be next week on Friday, October 21<sup>st</sup>. Lastly, the next House competition will be team dodge ball.

Mr. Hayek reported that the traditional Ivy HS Thanksgiving Dinner will be taking place the week before Thanksgiving Break. Ivy HS is preparing for a midyear 2 day review by the WASC Committee. Students at Ivy HS will also be taking the PSATs. Seniors on those days will be working on their community service hours for graduation requirements. Mr. Hayek also shared he was able to attend a Model Continuation School training. He will now be part of a visiting team which will definitely benefit Ivy as he brings ideas back to our school. The Myrtle Creek field trip was a fantastic day in photography. Students were engaged for 2 to 3 hours. He was able to sit through student appointments at Oasis HS and observe students and teachers. He also is very proud of Oasis HS student Emily Vu for being honored at Student of the Month.

E. Reports from Superintendent: Dr. Pedroza shared how impressed he was with Homecoming. A lot of red and white full of spirit and pride. He was honored to have been selected to judge the floats. It was incredible to have, for the first time, our own color guard to open the game and was so impressed they were all young ladies. Dr. Pedroza also congratulated Mr. Bickel in the audience as his son was also honored at the Student of the Month Breakfast.
