## PRESENTATION/REPORT

Ms. Margaret Chapman, Mr. Doug Sehnert, and Mr. Scott Duffin introduced the students and reviewed all the awards the Ag students received at the San Diego County Fair over the summer and also the awards received at the National FFA Conference. Our Ag students truly had a stellar year. The Board of Trustees congratulated the students, teachers and parents for all their hard work.

#### COMMUNICATION AND REPORTS

A. Report from Student Board Representatives: Gabrielle reported that students are starting to make headway on the Festival of Cultures Pep Rally as well as the Winter Dance. The Winter Dance has been switched now to an informal dance with the theme of Ice Ice Baby. FHS students are doing their annual food drive and all are invited to contribute.

# B. Report from Camp Pendleton Representative:

Mr. Redding reported that the tree lighting ceremony on Camp Pendleton will be taking place this Saturday. It will be taking place at the Exchange on the Pacific side of the base. Community is invited to come out and participate.

C. Report from Board Members: Ms. Ludwig - No report.

Mr. Goodlake – Congratulated Ms. Koehler and Mr. De Meo for their reelection to the FUHSD Board of Trustees.

Mr. De Meo - Absent.

Mr. O'Donnell - He congratulated and recognized Mr. Antonio Robles. He is a recent graduate of FHS. Appreciated the fact he has been in attendance to our Board meeting and that he put his name in to run for a seat on the Board. Feels it really says a lot about our graduates and believes he will be on the Board in the future.

D. Reports from Principals: Mr. Hayek reported that dual enrollment within our schools here at FUHSD extends beyond athletics. Oasis students are also part of the Ag Dept. and congratulated those students present from Oasis HS for their accomplishments. Mr. Hayek said he and the Oasis teachers attended the California Consortium for Independent Study Conference last week and they brought a lot of strategies. It was a nice way to utilize Google Docs in a collaborative effort in real time. He reminded everyone that the Thanksgiving Feast at Ivy HS was taking place on Thursday, November 17<sup>th</sup>. He hopes everyone can make it. He was also happy to announce he had 24 students come out for the Ivy HS soccer team this year. Ivy HS also ended their trimester last week and 5 students graduated from Ivy. They

welcomed 10 new students from FHS and honored two students for Student of the Month.

Mr. Boone reported that he and the math department just returned from an excellent math conference put on by the California Mathematics Council. Progress reports should be going out soon. He reminded everyone this will be the last time progress reports will be mailed to all student homes. The next progress reports will only be mailed to those students with Ds or Fs. All progress reports can be viewed online. All report cards will be mailed to all students. Mr. Boone shared that the school is having two fund raisers at two local restaurants. PTSA is having a fundraiser at Jersey Mike's tomorrow and ASB is having their fundraiser at Panda Express on Wednesday, so make sure to say you are there for FHS. This is the second week of the Interim Assessment. Planning continues for the Every 15 Minutes Program. A very serious program to teach students the consequences of drinking and driving. Curriculum walks are planned for this week at FHS. The monthly college night will be taking place on November 17th. UC/CSU Admissions will be the topic. On Friday Mr. Boone will be hosting Coffee with the Principal at 9:00 a.m. He will also be hosting a Restorative Practices Symposium with the parents at the end of the month. And he is excited to be working with Palomar College on adding four new Palomar classes (math, speech, counseling, and history) for our students to be offered during zero period or seventh period.

E. Reports from Superintendent: Dr. Pedroza expressed how the presentation by the Ag Dept is what we strive for. Sharing what they can do and the accolades they have received in this very impressive program is amazing. We truly appreciate all the hard work by students, staff and parents. He encouraged everyone to continue in this wonderful program. Dr. Pedroza publically thanked the entire Fallbrook community for their support in passing the Bond (Measure AA). "Thank you so much for the vote of confidence. We will do what we need to do to be transparent and provide everything our students need." Thanked the community for the faith and trust they have placed in us. He asked Dr. Iniguez to present the next news on another of our programs and student successes.

Dr. Iniguez spoke very briefly on the Robotics Competition that our students participated in. Our team walked away with the Safety and Engineering Award. Our students placed 24<sup>th</sup> overall, 15<sup>th</sup> in programming and 15<sup>th</sup> in Driving. This is an incredible competition with judges from corporations like Hewlett Packard and NASA. The next competition for our students will be on Saturday at Otay Ranch HS and will begin at 9:00 a.m.

A representative from the office of Senator Joel Anderson thanked everyone for the incredible job they do with all the students. She encourages everyone to continue their hard work.
